**2011 SARATOGA WOODS SWIM TEAM**  
**WAIVER AND RELEASE**

The Saratoga Woods Swim Team is a member of the Junipero Serra Swim League. The League requires all member clubs, including Saratoga Woods, to obtain a waiver and release of liability from each swimmer who will participate in any Saratoga Woods and/or League swim team activities in favor of the League and all member clubs, officials, coaches and representatives. This means that upon joining the Saratoga Woods Swim Team, you agree, on behalf of you and your child, not to make any claim arising out of an injury to your child during swim team activities against the League, its member clubs or associated persons.

Upon signing the waiver and release below, paying the required fee and joining the swim team, your child will automatically be covered by a group accident insurance policy obtained by the League. Covered activities include all meets and practice sessions between now and July 23, 2011, the date of the League's Championship Meet. Upon signing the waiver, you are agreeing that your exclusive remedy against the League, its member clubs and associated persons for any claim arising out an injury to your child will be to make a claim under the League's group insurance policy.

The Member Clubs of the Junipero Serra Swim League are: Brookside Club of Saratoga, Eichler Swim and Tennis Club, Laurelwood Cabana Club, Cupertino Hills Swim & Racquet Club, Saratoga Woods Swim Club and Greenmeadow Community Association.

I (we) also agree that in the event my said minor child requires emergency medical treatment during any Swim Team function, he or she may be taken to the closest available hospital or medical clinic for any such emergency treatment if the family physician is not readily available to provide the treatment.

**WAIVER AND RELEASE**

TO INDUCE JUNIPERO SERRA SWIM LEAGUE AND ALL MEMBER CLUBS LISTED ABOVE TO ACCEPT REGISTRATION AND PERMIT PATICIPATION IN THE SWIM TEAM ACTIVITIES BY MY CHILD (REN), I, THE PARENT OR GUARDIAN OF SAID INDIVIDUAL, HEREBY GIVE MY CONSENT AND AGREE TO RELEASE, INDEMNIFY AND HOLD HARMLESS JUNIPERO SERRA SWIM LEAGUE AND ALL MEMBER CLUBS, THEIR OFFICIALS, COACHES AND REPRESENTATIVES FROM ANY CLAIM ARISING OUT OF AN INJURY TO MY CHILD (REN).
